Donate a Car Canada Inc. will act as an agent for the donor in procuring vehicular assets, the net proceeds of which will be donated to this charity. It is understood that the donor is in fact donating the net proceeds from the sale of their vehicle, and not the vehicle itself to the charity. This may be hereby referred to as "donated vehicle". These vehicles will be sold either by public auction, for recycle or private treaty, whichever sale method is deemed to maximize the monetary returns. Donate a Car Canada Inc. will handle the entire process from procurement of units, marketing, preparation for sale, actual sale and remittance of net proceeds on behalf of the donor to the charity. Donated vehicles will be subject to expense and deductions involved in the sale which may include but are not limited to tow and/or pickup charges, auction costs, vehicle repairs, cleaning, fuel, lien checks, and administration costs.

When marketing donated assets for sale, Donate a Car Canada Inc. shall have the authority to use the provided logo and trademarks for the above named charity/division as it pertains to listing our partnering charities on the website. Reciprocation of cross linking on each website is required to be implemented within 3 months for the entirety of the partnership between both Donate a Car Canada Inc. and the above named charity/division to ensure maximum exposure in promoting the donation of vehicles thus drawing awareness to the charity. The above named charity gives permission to receive email communications from Donate a Car Canada and it's employees as pertains to the partnering relationship.

All donated vehicles will be sold with a clear title. Lien checks will be performed on all vehicles to ensure there are no legal problems with the sale of the donated vehicle. When a vehicle has been sold and paid for, Donate a Car Canada Inc. undertakes to remit to the above named charity/division within 15 (fifteen) days, the net sale proceeds for each individual donor and their corresponding name and address for receipting purposes. Within 45 (forty-five) days of receiving the net proceeds, the charity/division undertakes to furnish the donor with a tax receipt that follows the guidelines set forth by the Canada Revenue Agency. **The donor's name is not to be added to any mailing or contact lists, unless otherwise stated on the donation notification from Donate A Car Canada Inc. as authorized by the donor.**

This contract remains in effect until such time that either party decides to terminate partnership agreement by providing written notice. If either party decides to terminate this agreement, both parties will agree to remove the reciprocating links and logo (if applicable) within 30 days of termination.
